



Good morning Premier,

Once again, MCUA representatives are requesting a meeting, to discuss existing, Cannabis patients/consumers in our community's rights, to treatment and the lack of legal protection, forcing more and more people each day to 'defy' the archaic, groundless laws surrounding Cannabis.

After the Community Cabinet, where MCUA representatives were instructed by your Health Minister, to "Encourage more people to use Marijuana" we have followed his advice and as an example, at your recent Persistent Pain Management strategy focus group, where a Qld Health representative was present, after Cannabis treatments were discussed by several people, not just myself, every single person at that meeting requested an MCUA business card! An 85 year old patient, attending that meeting, has since phoned me, begging for assistance where Qld Health and conventional medicine is failing her. Forcing her to live a painful life, confined for the most part to her home! You would deny patients, just like this relief? In light of the multitude of serious issues within the Queensland Health system, as just some are listed below:-

The Health Ombudsman has received 26 complaints concerning treatment at Lady Cilento Children's Hospital since it's opening on November 29 last year. A further 27 reports of children who had died either at the hospital or after having "recently received care from LCCH" since its opening have been received by the State Coroner. A spokesman for the Coroner told The Courier-Mail that of those reports, 17 remain open investigations, while five were specific to health care received at the hospital. Two of those investigations remain open.

Whilst we point out that Cannabis Medicine is going from strength to strength, you continue to ignore us. Each Member of Parliament, swore an oath, as attached to "I will well and truly serve the people of Queensland and faithfully perform the duties and responsibilities of a member of the Legislative Assembly to the best of my ability and according to law". If you refuse to abide by this oath, why then should Queenslanders, who are your EMPLOYERS, abide by Qld laws which serve no other purpose than to harm us?

Whilst the govt is trying to make everyone think they are being so progressive, the international treaty has ALWAYS allowed for medical use and our govt has failed the people of Australia for 46 years MCUA are aware of moves afoot to raise a high court challenge - the people vs the govt - for that very reason - the govt has withheld medical relief from the people of Australia despite the UN's single convention saying that countries must make adequate provision for the medical and scientific use of cannabis.

We hereby advise you, that MCUA will be continuing to absorb the refugees, from your failing Health Care System and will be proceeding to fulfil the quality of life and relief of our various disease symptoms and basic Human requirements of our members.

MCUA continues to hold out the hand of cooperation to work with the Queensland Government, to ensure that every single patient has the right not only to Cannabis treatments but to their choice of treatment. Standardized pharmaceutical preparations as an only option, will never be recognized by thousands and thousands of those who already experience relief via WHOLE PLANT THERAPIES. Proven time and time and time again to be the only effective way to treat the majority of Cannabis patients. I speak now, not only as a representative of MCUA or as a patient, but now, as a qualified, Cannabis Clinician

In closing, this correspondence has been sent in hope to maintain communication between your departments and our members. We have already well and truly reached and passed the watershed moment on this subject and we are no longer going to hide this in the dark. It's time to put patient care first
